

With a single paragraph, the governor of New Hampshire announced his intention to combine the state's 13 four- and two-year public colleges into one unified system. Gov. Chris Sununu, a Republican, included the proposal in the executive summary of his budget for the 2022-23 fiscal years, released this week.

New Hampshire joins a growing number of states, including Pennsylvania, Maine and Connecticut, that are turning to different forms of public-college mergers in response to ebbing numbers of high-school graduates and increased competition


## **Themes of Proposed Consolidations**

- Unfavorable demographic conditions
- Institutions involved serve critical constituencies
- Deference to institutional autonomy contributes to external intervention
- Pressure from new providers




## **Vermont State College Campus Locations**






Educational Attainment, Associate's+, 2014-18



Projected Population Change 2010-30






CCSNH SUPPORTS NH RESIDENTS, COMMUNITIES System of New Hamps AND NH'S REGIONAL LABOR MARKETS

- CCSNH is agile to meet needs as they emerge




## High School Graduates by Region (Actuals through 2020)


# Cumulative Percent Change in FTE Enrollment in Public Institutions (Relative to 2010), U.S. and Selected States


### **Student Share of Total Education Revenue**


#### Revenue Minus Expenditures, Vermont State College Institutions

#### Institutional Headcount and Discount Rate at VSC Institutions






#### **Vermont**


- 1. Proposal to close NVU and the Randolph campus of VTC (Spring 2020)
- Public outcry leads to legislation creating the Select Committee on the Future of Public Higher Education in Vermont. NCHEMS hired as consultant to conduct analyses, facilitate and prepare reports. (NEBHE assisted)
- 3. Deliberate, data-informed process culminates in report endorsed by all Select Committee members (April 2021) (<a href="https://www.vsc.edu/transformation/">https://www.vsc.edu/transformation/</a>)
- 4. Report recommendations
  - a. Consolidate three VSCS institutions; maintain CCV as separate
  - Maintain existing sites with shared academic delivery of programs and resources, including student services
  - c. Administrative consolidations
  - d. State funding to support these transformations over multiple years
  - e. Others: affordability, board development, economic development
  - f. Implementation steps for all parties
- 5. Select Committee report cued up a transformation plan adopted by VSC board and leadership

# Enrollment by College FY20 (does not include Running Start or non-credit)








## **New Hampshire**

- Governor proposed merging USNH and CCSNH in his budget proposal during the 2021 session
- Intent was to reduce duplication and save money immediately, improve student mobility
- Proposal generated many questions and was not included in the final budget passed by the legislature
- Questions
  - Maintaining focus on CCSNH's workforce mission
  - Presence throughout the state
  - Reconciling different cost structures and collective bargaining agreements

## **Summary**

- Short-term costs
- Mergers vs. Consolidations
  - Costs of closure
  - Mergers of systems ≠ mergers of institutions
  - Functions vs. institutions
- Pursuing consolidation
  - Clear objectives focused on constituents (students, employers, community) and rationale
  - Recognition of distinct missions
  - Cultural features—branding and symbols, history, approaches to governance, etc.
  - Funding requirements to institutionalize new arrangements
  - Transparency, voice, and data/evidence
  - Bold and decisive board actions to create conditions and criteria for success
- Solutions must fit the context
